3. The different ICA Committees are hereby directed to transact only with the managers of the companies on the list provided or their duly authorized representative as supported by Special Power of Attorney (SPA) or valid contract agreement to avoid inconvenience.

4. Likewise, **COC holders for PNP GOA Uniform for workmanship** must present a valid contract of agreement with the **COC holder for fabric** stating therein that the former will procure from the latter the authorized fabric. Said contract must be submitted by the supplier to the concerned ICA Committee before joining the acquisition process to ensure that the source of fabric is authorized and that the proponent can supply the required uniforms once chosen by the Recruit Acquisition Committee (RAC).
